**The reason for deadline extension:** Having regard to the fact that the interested parties suggested that due to the large amounts of bank guarantees and the end of the current year banks need more time to process and issue those guarantees, the commission accepted the suggestions and extended the tender submission deadline.

**Time and place of tender submission (new deadline):** Tenderers shall submit tenders, directly or by post, in a sealed and stamped envelope or a box, to the Contracting Authority's address: Pension and Disability Insurance Fund of the Republic of Serbia, 9 Dr. Aleksandra Kostića Street, Belgrade, office no. 45 (hereinafter: Contracting Authority's address), by the deadline for tender submission specified in the call for tender submission published on the Public Procurement Portal of the public Procurement

Office and the website of the Contracting Authority, i.e., until **20/12/2018, no later than 11:00**, with the indication: THE TENDER FOR PUBLIC PROCUREMENT OF WORKS IN NEGOTIATION PROCEDURE WITHOUT PUBLISHING THE CALL FOR TENDER SUBMISSION: **Execution of the construction works on the building of Novi Sad branch, PP 98/2018 – DO NOT OPEN.** The back of the envelope or the box must contain the name and address of the tenderer, telephone, fax, e-mail address and the contact person.

**Tender opening time and place:** shall be public, on **20/12/2018, at 11:30** in the premises of the Pension and Disability Insurance Fund of the Republic of Serbia, 9 Dr. Aleksandra Kostića Street, Belgrade, in the Grand hall on the third floor, office no. 301.

**Contact person**: A tenderer may ask for additional information or clarification related to the tender preparation in written form, where he may indicate to the Contracting Authority the possible shortcomings and irregularities in tender documentation, provided that the communication in the public procurement procedure is done via post, e-mail or fax. Written requests for clarification related to the call and the tender documentation shall be sent no later than five days before the tender submission deadline in writing, as follows: via post to the address of the Pension and Disability Insurance Fund of the Republic of Serbia, 9 Dr. Aleksandra Kostića Street, Belgrade; Procurement department, to fax no. 011/206-12-29, or to e-mail address javnenabavke@pio.rs during the office hours of the Contracting Authority (Monday - Friday, from 7:30-15:30). The requests sent by e-mail or fax after the office hours shall be considered as delivered on the next working day. The request must contain the following notice: "For Public procurement commission", as well as the title of the concerned procurement. Pursuant to the Article 20, paragraph 6 of the Public Procurement Law, the acknowledgement of the e-mail and/or fax receipt by the Contracting Authority is obligatory, as the proof of the delivery being made. The Contracting Authority is obliged to publish the answer on the public procurement portal, as well as on its website, within three days from the request receipt date.
